In terms of size, with 395 attorneys (as of 9/30/08), the firm placed 120th on the *National Law Journal's* 2008 NLJ 250 rankings. Schiff Hardin is a general practice law firm. Its expertise includes antitrust and trade regulation, commercial and corporate finance, energy, environmental law, financial institutions, labor and employment, real estate, tax, and white-collar crime. In addition to Chicago, its office locations include New York City and Washington, D.C.
